In 2001-2009 and 2015-2017, he served as the Director of the Legal department of the Russian Ministry of Foreign Affairs, and in 2009-2015, as the Russian Ambassador to the Netherlands and Permanent Representative to the Organisation for the Prohibition of Chemical Weapons. He was involved, particularly as an agent and head of his country delegations, in the settlement of interstate disputes through judicial, arbitral and other peaceful means. Roman is a titular member of the Institute of International Law, a former member and special rapporteur of the International Law Commission. He

is also an Adviser on public international law at the Moscow-based NGO International and comparative law research center.
