

**PRESS RELEASE****THE REPUBLIC OF INDONESIA DEPOSITS ITS INSTRUMENT OF ACCESSION TO THE  
1907 HAGUE CONVENTION FOR THE PACIFIC SETTLEMENT OF INTERNATIONAL DISPUTES**

THE HAGUE, 4 DECEMBER 2025

On Thursday, 4 December 2025, the Republic of Indonesia deposited its instrument of accession to the 1907 Hague Convention for the Pacific Settlement of International Disputes (the “1907 Hague Convention”) with the Ministry of Foreign Affairs of the Netherlands, the depository of the Convention. The Republic of Indonesia will thereby become a Contracting Party of the Permanent Court of Arbitration (the “PCA”), with effect from 2 February 2026.

The Republic of Indonesia’s instrument of accession was presented by H.E. Mr. L. Amrih Jinangkung, Director General of Legal Affairs and International Treaties at the Ministry of Foreign Affairs of the Republic of Indonesia, in the presence of the Secretary-General of the PCA, H.E. Dr. Hab. Marcin Czepelak. The receipt was confirmed by Mr. Jules van Eijndhoven, Head of the Treaties Division of the Netherlands Ministry of Foreign Affairs.

The Republic of Indonesia will be the 127<sup>th</sup> Contracting Party of the PCA.

The PCA welcomes this expression of support for its work and the peaceful settlement of international disputes.

### **Background on the Permanent Court of Arbitration**

The Permanent Court of Arbitration is an intergovernmental organization established by the 1899 Hague Convention on the Pacific Settlement of International Disputes. The PCA has 126 Contracting Parties. Headquartered at the Peace Palace in The Hague, the Netherlands, the PCA facilitates arbitration, conciliation, fact-finding, and other dispute resolution proceedings among various combinations of States, State entities, intergovernmental organizations, and private parties. The PCA's International Bureau is currently administering seven inter-state arbitrations, one other inter-state proceeding, 90 arbitrations arising under bilateral or multilateral investment treaties or national investment laws, 93 arbitrations arising under contracts involving a State or other public entity, and 2 other proceedings.
