Mr. ANTÔNIO HERMAN DE VASCONCELLOS BENJAMIN. Chief justice of the National High Court of Brazil, Chair Emeritus of the Global Judicial Institute on the Environment. Appointed Justice of the National High Court of Brazil (STJ) in 2006 by President Luiz Inacio Lula da Silva, Professor Antonio Herman Benjamin was a career Public Prosecutor of the State of Sao Paulo for over two decades, where he headed the Environmental Protection Division. He is the president of the Global Judicial Institute on the Environment (GJIE)-the organization that brings together Supreme Court Justices and judges from around the world who work with Environmental Law - and Secretary-General of the "International Advisory Council for Environmental Justice" of UNEP - The United Nations Environment Programme. Justice Benjamin is also president of the Brazilian Environmental Forum of Judges (FONAMA) and former Director of the L.L.M (Master degree) Programme of the National Judicial Academy of Brazil (ENFAM). Justice Benjamin is a former president of the IUCN World Commission on Environmental Law (WCEL), the Brazilian Fulbright Alumni Association and member of the UN Secretary General Legal Expert Group on Crimes against the Environment. Professor Benjamin has served as co-chair of INECE - The International Network for Environmental Compliance and Enforcement, president of the Environmental Committee of the Summit of Chief Justices of Ibero-America. During the 2012 Rio+20 Conference, he was the coordinator of the UNEP World Congress on Justice, Governance and Law for Environmental Sustainability Justice. Justice Benjamin was a professor at the Catholic University of Brasilia School of Law and has been a visiting professor and lecturer at prestigious academic institutions around the world. He is the founder and emeritus editor-in chief of the Brazilian Environmental Law Review, published by Thomson Reuters, the oldest publication of its kind in Latin America. He has codrafted several major Brazilian statutes, including the 1990 Consumer Protection Code, the 1992 Anti-Corruption Act, the 1994 Competition Act, the 1998 Crimes Against the Environment Act, the 2006 Forest Concession Act, the 2006 Atlantic Forest Act, and the 2012 Forest Code. He has authored, coauthored and edited over thirty books and articles in Brazil and abroad. Justice Benjamin has received several awards, honours and other recognitions in Brazil and abroad. He is a Knight ("Chevalier") of the National Order of the Legion of Honour ("Ordre National de la Legion d'Honneur") of France and a Commander ("Commandeur") of the Order of King Leopold of Belgium. He is the recipient of the 2015 Elizabeth Haub Prize for Environmental Law, awarded by Stockholm University and considered the most prestigious international distinction conferred upon an environmental legal expert. He is a Goodwill Ambassador for Environmental Justice of the Organization of American States -OAS. Prof. SIMONE BORG. Professor Simone Borg LL.D, LL.M. (Int law), Ph.D (IMLI) is Malta's Ambassador for Climate Action and is a resident academic at the University of Malta, a visiting professor at the IMO International Maritime Law Institute and has lectured at various Universities abroad. She is specialised in Climate law and policy and the Law of the Sea and Ocean Governance, particularly in relation to the conservation of living marine resources. Prof Borg started her career as a diplomat with the Ministry of Foreign Affairs and later headed the Legal and Multilateral Affairs department from 1992 to 2004 within the Ministry responsible for the Environment. During this time, she also drafted national environmental law and policy and was Malta's negotiator in various Environmental Multilateral Agreements, particularly in the climate change negotiations. She was also responsible for the transposition of the environmental *acquis communautaire* when Malta joined the European Union in 2004. In 2017, during Malta's tenure of the Presidency of the Council of the European Union, she chaired the EU working party on climate negotiations. During Malta's tenure as an elected member to the United Nations Security Council she has provided legal advice to government on Sea Level Rise and other climate and ocean governance related legal issues. She was appointed the OSCE's Special Representative on Climate Action to serve throughout Malta's chairpersonship of the Organization in 2024. Simone Borg has served as the first chairperson of the Occupational Health and Safety Authority and chaired the Post COVID Strategy Committee. Prof Borg is a member of the IUCN Commission on Environmental Law, a member of its sub-committee on the oceans. She has authored various International publications on environmental law in Malta, ocean governance and climate change. Her most recent publications focus on the climate-ocean
